

## **CBMS Privacy Policy**

#### What data do we collect?

CBMS collects the following data:

- Personal identification information (Name, email address, affiliation/institution, role in your institution, personal research profiles)
- Research experience and expertise (topics, previous experience)

### How do we collect your data?

You directly provide CBMS with most of the data we collect. We collect data and process data when you:

- Register online by subscribing to the newsletter.
- Fill the Google Form aiming to recruit new PC Members.
- Sending your information directly to any responsible by email.

## How will we use your data?

CBMS collects your data so that we can:

- Inviting you to be part of upcoming CBMS editions in different roles.
- Email you with information related with the CBMS and associated events.

Your data will be shared only between General/Program Chairs of different CBMS editions with the goal of having a list of potential PC Members to upcoming/future editions. The user who will receive this data can change from one year to another.



#### How do we store your data?

CBMS securely stores your data at Google Servers.

CBMS will keep all your data until you decide to remove it.

#### What are your data protection rights?

CBMS would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request CBMS for copies of your personal data.

**The right to rectification** – You have the right to request that CBMS correct any information you believe is inaccurate. You also have the right to request CBMS to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that CBMS erase your personal data.

**The right to restrict processing** – You have the right to request that CBMS restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to CBMS processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request CBMS transfer the data that we have collected to another organization, or directly to you, under certain conditions.

#### **Cookies**

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

## What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- Functionality CBMS uses these cookies so that we recognize you on our website and remember your previously selected preferences.
  These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- Advertising CBMS uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. CBMS sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.



### How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
